*Proposal Overview*

This proposal includes preliminary ideas for comprehensive assessment of all programming and services SST provides. Initial planning should include interviews with all staff responsible for each area; review of current assessment efforts; re/development mission statements, goals, and outcomes/objectives for each program or initiative; and development of quantitative and qualitative assessment measures based upon these measures. Professional development on assessment and assessment measures should be completed at the individual, small group, and unit level, under the direction of an assessment project manager, as designated by the unit AVC. Development of a comprehensive unit assessment plan would begin in fall 2016, with rolling implementation of assessment tools as they are developed, per unit priorities. All assessment measures would be in place for the 2017-2018 academic year, with semi-annual review (following the end of each sixteen-week semester) during a three year time frame, with comprehensive review and redevelopment on a rolling, three-year basis. Research suggests that a three year time frame is appropriate for creation of a culture of outcomes-based assessment that utilizes results to improve programming and services. These measures are intended to meet the unit AVC vision of: improved student satisfaction; improved student learning and application; and measuring/improving the effectiveness of departmental efforts to meet the needs of students in transition.
